WASHINGTON, APPROVING THE PURCHASE OF THE PROPERTY COMMONLY KNOWN AS 3943 HWY 292, LOON LAKE, WASHINGTON 99148 FROM GEORGE RENNER; SETTING THE PURCHASE PRICE THEREOF; AUTHORIZING THE LIBRARY DIRECTOR TO NEGOTIATE THE TERMS OF PURCHASE AND EXECUTE ON BEHALF OF THE DISTRICT ALL NECESSARY DOCUMENTS RELATED TO SUCH PURCHASE: AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF STEVENS COUNTY RURAL LIBRARY DISTRICT, STEVENS COUNTY, WASHINGTON, as follows:

WHEREAS, Stevens County Rural Library District, Stevens County, Washington (the 'District') is a rural county library district duly organized and existing under and by virtue of the Constitution and laws of the state of Washington (the "State") now in effect; and

WHEREAS, it is a policy of the State to promote public library service through its various subdivisions;

WHEREAS, the District was organized as a rural library district to provide library services within its boundaries, and over time the District has expanded its service throughout its boundaries; and

WHEREAS, the District now has an opportunity to expand its services by acquiring the property in Loon Lake, Washington.

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED as follows:

- **Section 1. Approval of Purchase.** The purchase and acquisition of the property and building located at 3943 Hwy 292, Loon Lake, Washington 99148, for the negotiated price of \$150,000.00, is hereby approved.
- Section 2. Delegation of Authority. The Library Director is hereby authorized, on behalf of the Board of Trustees, except as may be limited by State law or regulation, to negotiate the terms of such sale, and to execute all documents pertinent and necessary to complete the purchase of the building, including but not limited to a Purchase and Sale Agreement.
- Section 3. Ratification. All actions not inconsistent with the provisions of this resolution heretofore taken by the Board and the District's employees with respect to the adoption of this resolution, are hereby in all respects ratified, approved and confirmed.
- Section 4. Repealer. All resolutions or parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed, and shall have no further force or effect.

Section 5. Effective Date. This resolution shall be in full force and effect from and after its adoption.
